

## **NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the Board of Supervisors of the Township of Charleston, Tioga County, Pennsylvania, shall hold a public hearing and a special meeting to consider adopting an Ordinance to amend Ordinance No. 124, to update compensation for the Township Supervisors. The Supervisors will conduct the public hearing and special meeting on January 20, 2026, at 7:00 P.M. at the Charleston Township Offices located at 156 Catlin Hollow Road, Wellsboro, Pennsylvania 16901, to consider the above matters.

A brief summary of the proposed Ordinance is as follows: Section 1 incorporates recitals; Section 2 amends Ordinance No. 124 to set the compensation of Township Supervisors to be One Hundred Thirty-One (\$131.04) Dollars and Four Cents for each meeting attended by the Supervisor, with an annual maximum of Three Thousand One Hundred Forty-Five (\$3,145.00) Dollars. The Ordinance includes a Severability clause and Repealer clause, and sets forth an Effective Date.

**AN ORDINANCE**

**OF THE TOWNSHIP OF CHARLESTON AMENDING AND  
UPDATING ORDINANCE NO. 124, RELATING TO  
COMPENSATION OF TOWNSHIP SUPERVISORS.**

**WHEREAS**, the Second Class Township Code establishes the annual maximum compensation for township supervisors based on the township's population (see 53 P.S. § 65606), and that for townships with a population not more than 4,999, the annual maximum compensation shall be Three Thousand One Hundred Forty-Five (\$3,145.00) Dollars; and

**WHEREAS**, the Second Class Township Code authorizes the board of supervisors of a township to establish the compensation for township supervisors, subject to various provisions of the Code; and

**WHEREAS**, since the enactment of Ordinance No. 124, establishing the compensation for Charleston Township Supervisors, the annual maximum compensation for township supervisors in Section 65606 of the Township Code has been increased; and

**WHEREAS**, the Board of Supervisors of Charleston Township have determined that the compensation of Charleston Township Supervisors shall be on a per meeting basis and shall be within the maximums set forth in the Second Class Township Code.

**NOW, THEREFORE, IT IS HEREBY ORDAINED AN ENACTED**, by the Board of Supervisors of Charleston Township, Tioga County, Pennsylvania, as set forth herein.

**Section 1.** The foregoing recitals are incorporated herein.

**Section 2.** Paragraph 1 of Ordinance No. 124 shall be amended to read as follows:

1. Each supervisor of Charleston Township elected or appointed to office after the effective date of this Ordinance shall receive compensation for attending duly advertised general or special public meetings authorized by the Board of Supervisors at the rate of One Hundred Thirty-One (\$131.04) Dollars and Four Cents for each meeting attended by such Supervisor, not to exceed Three Thousand One Hundred Forty-Five (\$3,145.00) Dollars per year.

**SEVERABILITY.** The provisions of this Ordinance are severable, and if any of its sections, clauses or sentences shall be held unlawful, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining provisions of this Ordinance.

**REPEALER.** All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

**EFFECTIVE DATE.** This Ordinance shall become effective upon enactment.
