

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Board of Supervisors of the Township of Charleston, Tioga County, Pennsylvania, shall hold a public hearing and a special meeting to consider adopting an Ordinance to amend Ordinance No. 111, regulating collection and disposal of solid waste. The Supervisors will conduct the public hearing and special meeting on January 20, 2026, at 7:00 P.M. at the Charleston Township Offices located at 156 Catlin Hollow Road, Wellsboro, Pennsylvania 16901, to consider the above matters.

A brief summary of the proposed Ordinance is as follows: Section 1 removes Sections 5, 6, 7, 8, 10, and 12 of the current Ordinance; Section 2 amends Section 4 of the current Ordinance to require any person who engages in activities covered by the Ordinance to comply with all state laws and regulations, to have all necessary permits and approvals, and to provide the Township with copies of licenses, permits, insurance, or other necessary documents; Section 3 amends Section 7 of the current Ordinance to require all agreements for removal and collection of garbage to be by private contract between a citizen and a licensed hauler. The Ordinance includes a Severability clause and Repealer clause, and sets forth an Effective Date.

AN ORDINANCE

**OF THE TOWNSHIP OF CHARLESTON AMENDING AND
UPDATING ORDINANCE NO. 111, REFUSE, REGULATING
COLLECTION AND DISPOSAL OF SOLID WASTE, TO
REMOVE UNNECESSARY PROVISIONS, TO REQUIRE
COMPLIANCE WITH ALL APPLICABLE STATE LAWS
AND REGULATIONS, AND TO UPDATE ENFORCEMENT
AND PENALTIES.**

WHEREAS, the Township of Charleston (hereinafter the “Township”) has determined that the appropriate regulation of refuse and solid waste collection and disposal is essential to the general health, welfare, and safety of Township residents, and prevents nuisances and other dangerous conditions; and

WHEREAS, the Township Supervisors have determined that several provisions of the existing solid waste collection and disposal Ordinance (Ordinance No. 111) are unnecessary and should be removed, or are outdated and should be updated.

NOW, THEREFORE, IT IS HEREBY ORDAINED AN ENACTED, by the Board of Supervisors of Charleston Township, Tioga County, Pennsylvania, as set forth herein.

Section 1. The following Sections of Ordinance No. 111 shall be removed:

- SECTION FIVE: FAILURE TO COMPLY.
- SECTION SIX: FIXING RATES.
- SECTION EIGHT.
- SECTION TEN: PREPARATION.
- SECTION TWELVE: PAYMENT OF FEES.

Section 2. Amendments to SECTION FOUR of Ordinance No. 111.

SECTION FOUR: LICENSE shall be amended to read as follows:

SECTION FOUR: COMPLIANCE AND APPROVALS – Any person who hauls, transports, collects, removes, or disposes of garbage, refuse, rubbish, or riff-raff over the streets and alleys of the Township must comply with all applicable state laws and regulations, and must have all necessary permits and approvals. Upon request by the Township, such person shall provide the Township with a copy of any license, permit, insurance, approval, or other document related to conduct set forth in this Section.

Section 3. Amendments to SECTION SEVEN of Ordinance No. 111.

SECTION SEVEN: PRIVATE AGREEMENTS shall be amended by removing all of the provisions related to rates and charges, and shall read as follows:

SECTION SEVEN: PRIVATE AGREEMENTS – All agreements for removal and collection of rubbish, garbage, refuse or riff-raff shall be by private contract between the individual citizen and the hauler licensed for the purpose of collecting, removing, hauling and disposing of such rubbish, garbage, refuse material and riff-raff.

SEVERABILITY. The provisions of this Ordinance are severable, and if any of its sections, clauses or sentences shall be held unlawful, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining provisions of this Ordinance.

REPEALER. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

EFFECTIVE DATE. This Ordinance shall become effective upon enactment.
